Concordia College will again provide Summer Ministry Grants for the 2009-10 academic year to students working as **Bible Camp** counselors during the 2009 summer season. Because of the generosity of Joyce and Harley Carlson, the value of the scholarship is \$300.

This program has been in operation for 18 years now. To ensure its continued smooth operation, we again remind you of the program guidelines:

1. The Summer Ministry Grant is applied to the academic year following the summer worked and is divided equally between semesters.
2. **Camp directors must inform the Financial Aid Office by June 1, 2009 of the name of the Concordia students hired for summer 2009 Bible Camp.**
3. Camp directors must verify that the student worked the full camping season. If you hire a student and notify us and they subsequently do not work at all or for the entire season, please notify us in writing.
4. Counselors-in-training are not eligible for this grant.
5. The grant will appear on the Financial Aid Award Letter the student receives for the 2009-10 academic year. This letter is sent after receipt of the results of the FAFSA and other forms that the Financial Aid Office may request.
6. This Summer Ministry Grant form will also be distributed to students who received the Summer Ministry Grant during 2008-09. **However, it is your responsibility to fill it in and return it to the Financial Aid Office by the deadline.** Be sure to provide the hometown and middle initial of the students as we have several students with the same names!
